For fiscal year 2021-2022 only, a one-time premium pay COVID-19 supplement of one thousand dollars (\$1,000) will be provided to eligible employees. Eligible employees include those in a regularly established position and in an active paid status as of July 1, 2021.

The supplement will be paid in full by October 2021.
